ADDENDUM - ADDITIONAL TERMS FOR VALIDATION SERVICE

Validation service for the aforementioned Instrument will be performed by Sequence, Inc., a bioMérieux subcontractor. Upon Customer's acceptance of the aforementioned quote, Customer shall be invoiced fifty (50) percent of the validation service cost, and Customer agrees to pay same within thirty (30) days of the invoice date. Upon completion of the validation service, Customer shall be invoiced the remaining fifty (50) percent of the validation service cost, and Customer agrees to pay same within thirty (30) days of the invoice date.

Upon request, Customer shall provide reasonably necessary information to bioMérieux and/or Sequence to facilitate a successful validation service. Customer shall ensure the Customer work environment is prepared and compatible for the validation service to take place. Customer's failure to provide reasonably necessary information and/or prepare a compatible environment within a reasonable time frame may result in postponement or cancellation of the validation service, triggering the payment penalties outlined below.

All cancellation notices must be provided in writing to bioMérieux. If the validation service is cancelled by the Customer within fifteen (15) days of the scheduled validation service, Customer shall be invoiced fifty (50) percent of the remaining half of the validation service cost, and Customer agrees to pay same within thirty (30) days of the invoice date. If the validation service is cancelled by the Customer within three (3) days of the scheduled validation service, Customer shall be invoiced the remaining half of the validation service cost, and Customer agrees to pay same within thirty (30) days of the invoice date. If the validation service is cancelled by Sequence, Inc., no payment penalties will occur.

If the validation service is postponed due to the Customer's actions, and bioMérieux incurs costs from Sequence, Inc. as a result of the postponement, Customer agrees to reimburse bioMérieux for same.

ADDENDUM - ADDITIONAL TERMS FOR VALIDATION SERVICE

Product Validation service by using the aforementioned Instrument will be performed by Bionique Testing Laboratories, Inc., a bioMérieux subcontractor. Upon Customer's acceptance of the aforementioned quote and the Purchase Order issued, Customer shall be invoiced fifty (50) percent of the validation service cost, which is non-refundable, and Customer agrees to pay same within thirty (30) days of the invoice date. Upon completion of the validation service, Customer shall be invoiced the remaining fifty (50) percent of the validation service cost, and Customer agrees to pay same within thirty (30) days of the invoice date.

Upon request, Customer shall provide reasonably necessary information to bioMérieux and/or Bionique to facilitate a successful validation service. Customer shall also provide Bionique with the necessary materials and/or strains within a reasonable time frame for Bionique to initiate the validation service.

Bionique will initiate the validation service upon receipt of the materials and/or strains from Customer. All cancellation notices must be provided in writing to bioMérieux. If the validation service is cancelled or postponed after Bionique's receipt of the materials and/or strains, and that cancellation or postponement is attributable to Customer, Customer shall be responsible for any costs resulting from services performed prior to the cancellation or postponement. If applicable, bioMérieux will invoice said costs to Customer, and Customer agrees to pay same within thirty (30) days of the invoice date.
